

As a member of the BPIF, click on the first icon 'Membership Services' and this is the screen you'll see;





HOW TO LOG IN

STEP 1 – Ensure you're logged as a 'User' within the BPIF website

Firstly make sure the person within your company to be accessing the website as a 'User' is recognised within the BPIF website as a contact – this can be checked by your company BPIF membership contact by reviewing the 'Manage my Company Account' section on the website.

If you're not logged as a contact you can be added within the 'Manage my Company Account' section which is where all preferences for ongoing communication can be managed.

STEP 2 – Now you're a 'User' – with your username create your password

Please note that when a new contact is added the email address used at that time will be the username.

If this is the first time accessing the website, please click on the following link to generate your password <https://www.britishprint.com/generate>

STEP 3 – As a 'User' or 'Returning User' – you should have a password

Insert your username – Click on 'Member Login' at the top right-hand side of the screen, and enter your username, this will be your email address, for example - j.smith@bpif.org.uk

Insert your password – within the next box insert your password to access the website – if you're using your day-to-day computer/laptop it would be useful to save your password for next time you access the website, therefore if asked select 'Yes, Save Password'.

Forgotten your Password – click on the 'Forgotten Password' section when you've inserted your username, and you'll be emailed an access password.


You'll be able to select and download each of the documents, which are in WORD format, to allow you to rebrand the documents, and make them relevant to your business.

BOOK YOUR HEALTH CHECK – ANALYSE THE HEALTH OF YOUR BUSINESS



All printers want to pride themselves on their health & safety management, but few measure themselves objectively and even fewer carry out independent reviews of their health & safety. The BPIF Health Check is a quick and easy review of current processes that will give you a clear work-to list of actions to improve where gaps have been identified.

For Platinum members the Health Check is a free of charge service, although Gold and Silver members have this service available to them at a cost – please contact your Regional HS&E Adviser for further information.

Once booked in, your regional Adviser will carry out a site tour of your premises and take you through a series of specific detailed questions about current practices on topics such as;

- Arrangements and management of health & safety
- Control of machinery and equipment hazards
- Transport and traffic routes on site
- COSHH and skin care
- Lifting, handling and upper limb disorder
- Working at height
- Health surveillance

All topics are based on the HSE legal requirements and best practice for the printing industry. You'll receive a hard copy detailed report showing any actions which will be required to reach compliance.

SEAL OF EXCELLENCE



The BPIF Seal of Excellence Award is a great way for individuals, departments and businesses to demonstrate their expertise both internally and to the print industry. Often the BPIF Seal of Excellence award is just one stage in a programme of continued improvement.

To achieve the BPIF Seal of Excellence, a minimum score of 80% must be scored and all mandatory areas must be passed. Members will be asked to have information prepared ready for the visit for verification purposes. Feedback will be given on the day and the company representative and the BPIF Adviser will agree the company position, and any improvement work that is needed. The BPIF Seal of Excellence audit will be carried out every two years and the company score must be maintained or improved during this period.

Where a company achieves a score of over 80% and passes all mandatory fields in three or more audits in any two-year period, then the company will be eligible for the ultimate accolade, the BPIF Seal of Business Excellence.

There will be no cost to Platinum members, whilst Gold and Silver members can pay for any audit and win any consequential Seals at the BPIF agreed daily rate.

LEGISLATION AND PROSECUTIONS



The Legal Register is a list of legislation applicable to the printing industry, it offers you a way to keep up to date with environmental and health & safety changes. As part of ISO 14001 and ISO 45001 you have a duty to ensure your activities have a minimal impact on the surrounding environment. As part of BPIF membership we provide access to a list, which gives you the basic updates for free to enable you to meet your requirements.

Since the new Sentencing Guidelines came into effect in February 2016, the fines handed to those found guilty of safety and health offences increased by 80% in 12 months, despite the fall in the number of cases prosecuted, the Health and Safety Executive's (HSE) injury and ill health statistics show.
